Purpose and legal basis of the processing

We will process your personal data for the following purposes:

- responding to your inquiries, the basis in this case is the need for processing in order to take action before concluding a contract at your request (Article 6(1)(b) of the Regulation¹),
- sending marketing information by means of electronic communication and automation programs under the Act of 18 July 2002 on providing services by electronic means and in conjunction with Article 172(1) of the Telecommunications Law of 16 July 2004 (alternative consent) based on your consent (Article 6(1)(a) of the Regulation).

Data retention period

Your personal data shall be kept for the period necessary to prepare and provide a response to your inquiry (no longer than 12 months from the date of sending) or until your consent to receive marketing information is withdrawn.

Recipients of personal data

In accordance with the applicable laws on personal data protection, your personal data:

- may be transferred to entities to which we outsource data processing services, including IT and marketing service providers. Such entities process data on the basis of a contract with us and only according to our instructions,
- may be transferred to entities that are entitled to receive them by law.

Your rights in relation to the processing of personal data

You have the following rights related to the processing of personal data:

- right of access to your personal data,
- right to request the correction of your personal data,
- right to transfer the data,
- right to request the deletion of your personal data under the conditions set out in Article 17 of the Regulation,
- right to request a restriction on the processing of your personal data under the conditions set out in Article 18 of the Regulation,
- right to withdraw your consent. You can exercise your rights at any time, the processing performed before the withdrawal of consent shall be considered fully legal.

Right of complaint

You have the right to lodge a complaint with the President of the Office for Personal Data Protection (to the address: Stawki 2, 00-193 Warszawa), if you consider the processing of your personal data to violate the provisions of the Regulation.

Transfers of personal data to third countries

Your personal data is stored on servers located in the European Union, but due to the fact that Asseco Data Systems S.A. uses cloud solutions provided by Microsoft, the data may be transferred – on the basis of standard data protection clauses – to a third country. Requirement to provide personal data

Providing personal data is entirely voluntary, but is required for preparing answers to your inquiries and preparing offers. The consequence of not providing personal data will be the lack of possibility of receiving an answer to your inquiries and offers as well as the lack of possibility of receiving information regarding the services and products offered by the Controller.

Automatic data processing and profiling

Your data shall not be processed in an automatic manner and shall not be subject to profiling.
